

RESOLUTION NO. 6826

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ARCADIA, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 10, 2012, AND DECLARING THE RESULTS THEREOF AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, an All Mail Ballot General Municipal Election was held and conducted in the City of Arcadia, California, on Tuesday, April 10, 2012, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in charter cities; and

WHEREAS, the City Clerk canvassed the returns of the election and has certified the results to this City Council, and the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ARCADIA, CALIFORNIA, DOES FIND, DETERMINE AND RESOLVE AS FOLLOWS:

SECTION 1. The whole number of vote by mail ballots cast in the City was 6,923.

SECTION 2. The names of persons voted for at the election for Member of the City Council are as follows:

John Wuo  
Mary E. Dougherty  
Henry Nunez

Gary A. Kovacic  
Sho Tay

The name of the person voted for at the election for City Clerk is as follows:

Gene Glasco

The measure voted upon at the election is as follows:

Measure "D" – Transient Occupancy Tax

SECTION 3. The number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates and for and against the measure are listed in Exhibit "A" attached.

SECTION 4. The City Council does declare and determine that:

John Wuo was elected as Member of the City Council for the full term of four (4) years and Gary A. Kovacic was elected as Member of the City Council for the full term of four (4) years; Gene Glasco was elected as City Clerk for the full term of four (4) years; and as a result of the election, a majority of voters on Measure D relating to a Transient Occupancy Tax did vote in favor of it, and the measure was carried, and shall be deemed adopted and ratified.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) the measure voted upon; (4) for what office each person was voted for; (5) the number of votes given at each precinct to each person, and for and against such measure; and (6) the total number of votes given to each person, and for and against such measure.


SECTION 6. The City Clerk shall administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. The City Clerk shall certify to the adoption of this Resolution.




