

RESOLUTION NO. 7122

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ARCADIA, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 12, 2016, AND DECLARING THE RESULTS AND OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, an All Mail Ballot General Municipal Election was held and conducted in the City of Arcadia, California, on Tuesday, April 12, 2016, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in charter cities; and

WHEREAS, the Chief Deputy City Clerk canvassed the returns of the election and has certified the results to this City Council, and the results are received, attached and made a part hereof as Exhibit "A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ARCADIA, CALIFORNIA, DOES FIND, DETERMINE AND RESOLVE AS FOLLOWS:

SECTION 1. The whole number of vote by mail ballots cast in the City was 8,993.

SECTION 2. The names of persons voted for at the election for Member of the City Council are as follows:

Bob Harbicht
April A. Verlato
Paul Van Fleet

Burton L. Brink
Sheng Chang
Peter Amundson

The name of the person voted for at the election for City Clerk is as follows:

Gene Glasco

The measure voted upon at the election is a follows:

Measure "A" – City's Utility Users Tax

SECTION 3. The number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates, and the number of votes with respect to the above Measure, are listed in Exhibit "A" attached hereto.

SECTION 4. The City Council does declare and determine that:

April A. Verlato and Peter Amundson were elected as Member of the City Council for the full term of four (4) years.

Gene Glasco was elected as City Clerk for the full term of four (4) years.

As a result of the election, a majority of the voters voting on Measure "A" did not vote in favor of it, and the measure was not carried.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the results of the election, showing: (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; (4) the number of votes given at each precinct to each person; and (5) the number of votes cast regarding Measure A.



The City Clerk shall administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been

elected.

SECTION 7. The City Clerk shall certify to the adoption of this Resolution.




