FILING REQUIREMENTS

- ☐ An Ownership Disclosure is required if the property is owned by a corporation, partnership, trust, or non-profit. The disclosure must reveal the agent for service of process or an officer of the ownership entity. The disclosure must list the names and addresses of all the owners, and you must attach a copy of the current corporate articles, partnership agreement, trust, or non-profit document, as applicable.
- ☐ Filing Fee - \$464
- ☐ One (1) PDF and one (1) hard copy of a report completed by an independent Certified Arborist.¹ The report must include an evaluation and determination regarding the condition/health of all Protected tree(s) on the property and those on adjacent properties that may be encroached upon or affected by the proposed project.² The report should state the potential effects of the encroachment(s) upon the Protected tree(s) as well as mitigation measures and protection measures that should be incorporated. The application will not be accepted without the Arborist's report.

¹ The Arborist must be certified by the International Society of Arboriculture. A list of local Certified Arborists is available from Planning Services.

² Mature trees, as defined under Development Code Section 9110.01.030.1, shall not be subject to encroachment permit requirements if they are not located on the property where development is proposed.

- ☐ A scaled site plan (11" x 17" maximum size) and a PDF version that shows the following:
 - ☐ The entire subject property identifying the species of all the Protected trees with their diameters and circumferences at a height of approximately 54 inches above the root crown, including any Protected trees on adjacent properties that may be encroached upon or affected by the proposed project.
 - ☐ All existing and proposed improvements, and all Protected trees on the property with their driplines/canopy edges accurately depicted.
