
Did you know?

Trash Cans

Trash cans can be placed at the curb no more than 24 hours before pick up and shall be stored out of public view by 5:00a.m. the day after collection.

Bulky Item Pick-Up

Waste Management offers four (4) free bulky item pick-ups per calendar year for each single-family residential account and two (2) for each multi-family residential account. Call 1-800-266-7551 to schedule.



Landscaping

Lawns and all landscaping need to be maintained in a neat and orderly manner.

Water, mow, and edge your lawn on a regular basis. Remove weeds, overgrown vegetation, and fill in bare landscaping. Go to www.ArcadiaCA.gov/RLG for more information.

Property Maintenance

Keep your property from looking abandoned by fixing or replacing exterior components that are broken or in disrepair. Be sure to also store inoperable vehicles, debris, and equipment out of public view.



Unoccupied Residences

Properties that are vacant for more than thirty (30) days need to be registered with the Development Services Department and should be maintained on a regular basis. Register unoccupied homes online at www.ArcadiaCA.gov/Unoccupied.



Unpermitted Uses

Short-term rentals such as Airbnb, home sharing, and any advertisements for such uses are not permitted.

Protected Trees

Before removing or trimming a protected tree, contact the Planning Division at (626) 574-5423 to acquire a tree permit.




Wildlife

The feeding of wildlife, including peacocks, is prohibited.

Green Pool

Pools and spas should be kept in working order so that the water is clear and free of vectors, pollutants and debris.
