

INTRODUCTION

The purpose of the Homeless Census is to determine a baseline population, key demographics, and vital information to better inform future homeless services and resource allocation. The Census is distinct from the HUD-mandated Point-in-Time Count as it allows for a more in-depth, city-specific focus on individuals experiencing homelessness within Arcadia. This is the second time the Homeless Census has been conducted in the City; the first was conducted in late 2021.

From September - November 2024, teams consisting of staff from the Recreation and Community Services Department, Police Department, and case managers from Arcadia's L.A. CADA team deployed to cover all census tracts within Arcadia.


Participation in the Census was optional and those who did not wish to partake were simply counted. In total, the teams encountered 121 individuals experiencing homelessness, 113 of whom agreed to partake in the Census. The Census consisted of 36 questions. Information and resources were offered and distributed to all individuals experiencing homelessness.

Census responses were collected electronically in a survey database. Duplicate entries of individuals were removed by comparing names and age ranges. All responses are self-attestations. Some percentage totals in the appendix may appear to be above or below 100.0% due to rounding.

Special thanks to staff from the Recreation and Community Services Department, Police Department, and the case managers from Arcadia's L.A. CADA team for their help in conducting the census and their continued efforts to assist Arcadia's most vulnerable residents. Additionally, thank you to the dozens of individuals experiencing homelessness who helped us gather this information.






















VICTIM OF DOMESTIC VIOLENCE



UNSHeltered WITH CHILDREN





WHAT CITY DO YOU USUALLY SPEND YOUR DAYS IN




WHAT CITY DO YOU USUALLY SLEEP IN




PRIMARY SLEEPING SITUATION





LOCATION OF LAST STABLE RESIDENCE





LOCATION OF HIGH SCHOOL ATTENDANCE





GROSS MONTHLY INCOME













STRUGGLE WITH MENTAL HEALTH













HOW OFTEN DO YOU GO HUNGRY






INTERESTED IN SHELTER IN ARCADIA



INTERESTED IN SHELTER OUTSIDE OF ARCADIA



Comparisons and analysis are based on Homeless Census data from surveys conducted in 2021 and 2024. Comparisons represent the change over this three year period.






